 - Simeon Stud is located 44km from SYD; travel time is 45 min to 1 hour

Australian Visas:

Most international travellers will need a visa to enter Australia. European Union & Schengen Area citizens, as well as passport holders from Great Britain, are eligible for an Electronic Travel Authority (ETA) visa (subclass 601), which costs \$20AUD and can be secured via online application. General requirements

<u>The course and all tests are conducted in English</u>. The participants are required to have good communicative use and understanding of the English language and be familiar with terms concerning conformation, skeleton, movement, etc. The assessment will be recorded for the internal use of the Instructors.

After the course the Instructors will evaluate all participants. The Instructors will consider results of the practical judging, theoretical knowledge, communication skills and general attitude.
